LICENSING SUB-COMMITTEE – SUMMARY OF DECISIONS

Licensing Sub-Committee (1) – Thursday 18th June 2015

Nando's, 67 – 68 Chandos Place, WC2N (St James's Ward/West End Stress Area) – Application for a variation of the premises licence to increase capacity to 250 people, changes to the layout of the premises, an additional condition to operate a Challenge 21 proof of age scheme, and to amend an existing condition relating to supply of alcohol. The Applicant's Representative proposed the Council's model restaurant condition, save that waiting staff would not be required to deliver alcohol to customers' tables and to allow for the current take away provision to continue as operated by Nando's restaurants elsewhere, as not permitting these could cause unnecessary annoyance to customers. The Applicant also contended that increasing capacity would be beneficial as it would prevent the need to turn customers away and putting them back onto the street. The Applicant had agreed to conditions requested by Environmental Health who had withdrawn their representation. The Metropolitan Police had made a representation requesting that the Applicant include the full restaurant model condition and objected to the increase in capacity as the site was located in a stress area.

The Sub-Committee granted the application with an amendment to the proposed restaurant model condition to include that the premises shall only operate as a Nando's Chicken restaurant. It also added a condition to the proposed restaurant model condition to include that no take away service of food or drink be provided for immediate consumption, as the Applicant had indicated that their take away service was not intended to provide this. The Sub-Committee took into account that although the premises was in a stress area, it was a food led establishment with hours only slightly extended beyond the core hours and it felt that with the proposed conditions, including that customers must be seated to consume alcohol, as well as the conditions added by the Sub-Committee, that the application would not adversely affect cumulative impact.

La Docta, Unit A15, Queensway Market, 23 – 25 Queensway, W2 (Lancaster Gate Ward/Bayswater Stress Area) – The application was granted under Delegated Authority as all representations had been withdrawn.

Barrio Central Restaurant & Bar, 6 Poland Street, W1F (West End Ward/West End Stress Area) – An application for a variation of the premises licence to increase capacity to 175, amend a condition to allow for consumption of off sales alcohol for customers seated outside the premises and additional conditions to promote and variations to some existing plans to be in accordance with a newly proposed condition. The Applicant's Representative confirmed that agreement had been reached with Environmental Health that maximum capacity be 105 for the basement and 75 for the ground floor, with a maximum overall capacity of 175 and he clarified that there was a small bench area outside the premises that customers used. He advised of changes to the originally proposed revised model restaurant condition to read that when the number of patrons on the premises exceeded 135, the additional patrons shall use the hatched area on the ground floor and this area shall then only operate as a restaurant. Environmental Health advised that although they had agreed conditions with the Applicant, they were objecting to the application on policy

grounds in respect of cumulative impact in a stress area and in relation to public nuisance.

The Sub-Committee felt that using the hatched area as a restaurant only once capacity exceeded 135 people would present practical difficulties in managing and enforcing, a point that was acknowledged by the Applicant. The Sub-Committee granted the application, with amendments to the revised model restaurant condition to read that the area hatched black on the ground floor shall only operate as a restaurant. For clarity, the Sub-Committee added further details to the maximum capacity condition, limiting it to 35 for the ground floor hatched restaurant area and 40 for the ground floor bar area. The Sub-Committee amended the proposed condition regarding seated patrons drinking outside the premises to limit the number to 4 people. It also added a condition that patrons permitted to temporarily leave and then re-enter the premises shall not be permitted to take drinks or glass containers with them, save the 4 seated people permitted to drink outside the premises.
